A Look Inside the Budgeting Process

As we enter fall we are also entering the busiest part of the budget season for the Falls Township government, and I think it's worthwhile to let our residents know what goes into the process. The Township's fiscal calendar is the same as the regular calendar, which spans January through December. The process of creating the budget is really a non-stop enterprise, involving a wide range of people.

The formal budgeting process starts in late summer when the Finance Department, led by Betsy Reukauf, begins by sending department directors their preliminary budget worksheets. Each director is asked to project their spending through the end of the year and estimate their budget needs for the new year for their respective department. The director is also required to submit any capital project requests for the next year. The department heads create their budgets using knowledge of issues and concerns they have gained throughout the year regarding existing equipment replacement or repair, new equipment needs, operational changes they have made which could lead to less money being needed for one thing or another, as well as many other items needed to keep the Township running properly and efficiently.

Once the year-end projections are made, Mrs. Reukauf uses them, along with her following year projections, to prepare a preliminary budget. Mrs. Reukauf also estimates the income the Township is likely to expect in the next year. Income enters the Township coffers in different ways, such as property taxes, permit and inspection fees, state aid for things like road repairs and police operations, income from Waste Management tipping fees, as well as fees from services such as the boat ramp, summer camp and other Park and Recreation programs. Creating a projection of what income is expected also involves analyzing trends for all those income sources over the past several years. Using trend analysis, the Finance Department also makes projections about future expenditures on things like salaries, insurance, fuel, electricity, etc. After these tasks are complete, Mrs. Reukauf forwards this information to the Township Manager, Peter Gray.

Mr. Gray reviews the preliminary budget with each department head to discuss the tentative budget for their department, working within a set amount of money he has allotted for each department. These allotments differ for each department with the Police Department receiving the largest share. Allotments for capital projects are based on all Township needs that become important and may not have been planned for. As an example, the Township will have to replace a bridge on South Olds Boulevard next year due to it failing a state inspection. This was unexpected and therefore will impact the amount of money allotted for other projects or operations. In some cases, department heads will ask for more than their allotment and then be asked to justify that request. Mr. Gray also meets with the Township Engineer, Jim Sullivan, to examine roads that need re-paving or reconstruction as part of the Road Program and plans which roads are most in need of work, and which can afford to be done.

Once the Manager's meetings with the department heads are complete and he has made suggested changes, he has individual discussions with members of the Board of Supervisors to seek their input on the budget and inform them of the discussions he has had with department heads and decisions he has made regarding the budget. In many ways these discussions with Board members simply reinforce discussions between the Manager and the Board throughout the entire year regarding personnel, projects and operations.

Once those discussions are complete, the Manager directs the Finance Director to finalize the budget draft and prepare a public presentation, which is always done during a Board meeting, usually in November. The budget is advertised and discussed in at least two Board meetings and then voted on by the Board in December. The budget is also displayed online, at local libraries and at the Township building for review by residents.

Anonymous Tip Line: 215-949-9120



Falls Township Police has created a tip line allowing the public to contact the Police department anonymously.

Members of the public are encouraged to report suspicious individuals or activity. Tips are then analyzed and passed on to the appropriate division for follow-up. Because the tip line is anonymous, the sender will not receive a response.

The tip line is not an emergency number. If you witness a crime in

progress or have an emergency that requires the police, please call 911.

Neighborhood Watch Program

Neighborhood Watch is a crime prevention program that enlists the active participation of residents in cooperation with law enforcement to reduce crime, solve problems, and improve the quality of life in your area.

Neighborhood Watch is a group of concerned citizens, joining together to assist local law enforcement in identifying and reporting suspicious or criminal activities in their neighborhoods.

Rapid Recovery Program



When an autistic child or an adult with Dementia wanders off and gets lost, finding them quickly can sometimes make a difference between life and death. The Rapid Recovery Program is a tracking system that consists of a small bracelet

worn by someone that is at risk of wandering. It is designed to locate missing special needs children, as well as Alzheimer and Dementia patients.

This bracelet transmits a signal for up to a one-mile radius, allowing search and rescue efforts to be quicker, finding the individual in minutes instead of hours.

This program is available to all Falls Township residents and surrounding communities.

Citizens Police Academy

Coffee with a Cop is just another way to allow our residents to make Falls Township a better place to live.

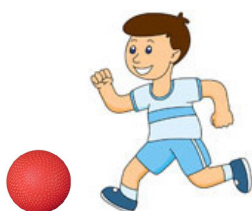

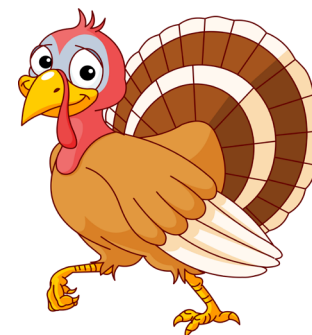
Youth Kickball

Community Raises Funds for Youth Police Academy

Thanks to generous contributions from two recent Township events, the Falls Township Youth Police Academy received a total of \$6,600 to support its program.

Extreme Fitness Personal Training owners Marty McLoughlin and his wife, Linda Stout, collected a total of \$5,600 in donations from the Fallsington 5K and one-mile walk. The couple presented a check to police officer John Yeager during a Falls Township Supervisors meeting.

In spite of having 200 fewer 5K participants, McLoughlin said the Township “did not lose in generosity.” Through the donations of local organizations and businesses, he was able to contribute even more funds this year as compared to 2017.

Recognizing that a 5K is “not some-

thing everyone wants to do,” McLoughlin said he has a “plan for next year to do things a little differently.” While details are still coming together, he told the Supervisors that he envisions holding an event at Falls Township Community Park.

Supervisor Jeff Boraski, who helped organize the township’s Touch-A-Truck event, said \$1,000 from that event’s fundraising efforts would be transferred to the Youth Police Academy.

Officer Yeager noted the “awesome partnership” the police have with Extreme Fitness Personal Training and others who help fundraise to support the program.

The Youth Police Academy is open to all students entering ninth- through 12th-grade, as well as 2018 high school graduates who are interested in law enforce-

ment or the military.

“The student has to go to school and not be a discipline problem,” Yeager said, adding that he requires a mandatory parent or guardian meeting to review the curriculum.

Youth Police Academy participants will learn about the crimes code, crime scene investigation, patrol scenarios, use of force, physical training and more.

Supervisor Chairman Bob Harvie lauded the donations as supporting a “good cause.”

“It’s been a tremendous success,” he said.

Law: Contractors Must Register With State

In 2008 the Commonwealth of Pennsylvania adopted the Home Improvement Consumer Protection Act 132 enforced by the Bureau of Consumer Protection in the Office of the Attorney General. It requires all contractors who enter into a contract with a homeowner for work more than \$500 to register with the state. Be sure the contractor you use meets the following requirements when entering into a home improvement contract for your property.

A contractor shall include its registration number in all advertisements, distributed and on all contracts, estimates and/or proposals with owners created by a contractor within the Commonwealth.

No home improvement contract shall be valid unless it:

1. Is in writing, legible and contains the home improvement contractor registration number of the performing contractor.
2. Is signed by the owner, his agent or other contracted party and the contractor or a salesperson on behalf of the contractor.
3. Contains the entire agreement between owner and contractor, including attached copies of all required notices.
4. Contains the date of the transaction.
5. Contains the name, address and telephone number of the contractor. Note: A post office box number alone shall not be considered an address.
6. Contains the approximate start and completion date.
7. Includes a description of the work to be performed, materials to be used and a set of specifications that cannot be changed without a written change order signed by the owner and contractor.

8. Includes the total sales price due under the contract.

9. Includes the amount of any down payment plus any amount advanced for the purchase of special order materials. The amount of the down payment and the cost of the special order materials must be listed separately.

10. Includes the names, addresses and telephone numbers of all subcontractors on the project known at the date of signing the contract. Note: A post office box number alone shall not be considered an address.

11. The contractor agrees to maintain liability insurance covering personal injury in an amount not less than \$50,000 and insurance covering property damage caused by the work of the home improvement contractor in an amount not less than \$50,000 and identifies the current amount of insurance coverage maintained at the time of signing the contract.

12. Includes the toll-free telephone number (888-520-6680) of the Office of the Attorney General's public access number to obtain information as to whether a contractor is registered with the bureau as well as information that may be obtained on the bureau's website: www.attorneygeneral.gov.

13. Includes a notice of the Right of Rescission i.e.:

a. "An individual signing a home improvement contract, except as provided in the emergency provision noted in the act shall be permitted to rescind the contract without penalty regardless of where the contract was signed, within three business days of the date of signing."

Know About Stormwater Management?

Falls Township is actively involved in a variety of programs and initiatives to meet various state and federal requirements for clean water.

We need your help to make a positive impact on our environment and the water that is so important to us all. Stormwater originates from rainfall and other precipitation that runs off of surfaces all over the Township - rooftops, streets, construction sites, lawns, fields, etc. Stormwater makes its way either along the surface or soaks into the ground. Surface water flows into swales, storm drains, and other natural water courses. As this water moves toward streams and rivers, it will pick up loose things on the ground with it. This can include pollutants, sediment, leaves and trash.

The Township is actively involved in meeting statutory permitting requirements under state and federal law. The water that soaks into the ground becomes part of the groundwater. For residents who get their water from wells, or our public water supplies, this becomes your drinking water. The Township is therefore developing a variety of programs and strategies to enhance water quality through plantings, mowing strategies, implementation of stormwater management facilities and other best management practices.

The Clean Water Act is the federal legislation that governs stormwater management. Stormwater point discharges to waters of the U.S. (pipes and drain pipes) are regulated using National Pollutant Discharge Elimination System (NPDES) permits. In 1999, federal regulations extended coverage of the NPDES program to Municipal Separate Storm Sewer Sys-



'Illicit Discharge' is the discharge of anything other than stormwater which flows directly or indirectly into the Township's storm sewer system. If you witness an illicit discharge, please call the Township at 215-949-9000 or submit your concern online.

tems (MS4) serving populations less than 100,000. Falls Township is an MS4 community and is required to comply with

PLEASE NOTE: Some stormwater facilities in the Township are private, including stormwater basins, swales, ponds, and similar facilities. This means the individual property owners or homeowners associations are responsible for the maintenance and upkeep of the facility. The Township does NOT maintain these private facilities. The Township does maintain the inlets and pipes within the public right-of-way.

the NPDES program. The Township is required to develop a stormwater management program that provides the details of how the community will comply with the requirements of the permit. Permits are based on a framework of six minimum control measures:

- **MCM 1** - Public education and outreach
- **MCM 2** - Public participation and involvement
- **MCM 3** - Illicit discharge detection and elimination
- **MCM 4** - Construction site runoff control
- **MCM 5** - Post-construction stormwater management in new development and redevelopment
- **MCM 6** - Pollution prevention and good housekeeping for municipal operations and maintenance

Check for Upcoming Waste Collection Dates

Falls Township will collect all yard waste, as well as leaves, at an upcoming date. Please check the Township website (www.fallstwp.com) or the Township Facebook page (<https://www.Facebook.com/fallstwp1/>) for those dates.

We will not accept yard waste with the regular trash.

Leaves **MUST** be bagged in 30-gallon biodegradable **PAPER BAGS** or placed in 30-gallon trash containers **WITHOUT LIDS**.

They are to be placed curbside by 6 a.m. on the designated collection day in the same location as your regular trash pickup. **LEAVES IN ANY OTHER CONTAINER WILL NOT BE COLLECTED.**

Christmas trees will also be collected at an upcoming date. This collection date will also be put on the Township website and Facebook page.

Students 'Top Cop' For a Day

For one day during the school year, elementary school students from Pennsbury and The Pen Ryn School get a first-hand look at life as the top cop through the police department's Chief for the Day program.

Falls Supervisor Chairman Bob Harvie said the governing body wholeheartedly welcomed the program, which began in 2017.

"This was not a hard decision for us to say 'absolutely,'" Harvie said.

Falls Township Police Chief William Wilcox recognized 17 fellow chiefs (for the day) during a Falls Township Supervisors meeting. Each of the six participating schools choose their respective chiefs. On the student's given day as chief, Wilcox takes the student to District Judge Jan Vislosky's court to be sworn in. Each takes an oath for the Falls Township Police department. From there, students receive an ID and lanyard and begin their day as chief.

Student chiefs have the opportunity to meet with lieutenants and answer questions.

"It necessitated them making decisions," Chief Wilcox said. "They made great decisions."

Perhaps the biggest was what to eat.

"They had their choice of whatever they wanted for lunch," Wilcox said.

As chief, students also have the opportunity to see the department's weaponry and gain a better understanding of fingerprinting and DNA. Kids also tour the processing room where prisoners are taken, get to see evidence and receive a tour around Falls Township.

Road Reconstruction Comes in Under Budget

The Falls Township Supervisors have set the wheels in motion for the full depth reconstruction of several roadways for less than the amount earmarked in the 2018 budget.

The Supervisors unanimously voted to award the 2018 road program to General Asphalt Paving Co., Inc. in the amount of \$2,207,644.40 – which amounts to \$300,000 under budget.

The governing body had reserved \$2.5 million for the full depth road reconstruction of Share Drive, the remaining portion of Walton Drive and a section of Lions Drive between Share Drive and Walton Drive.

Work is expected to begin toward the end of August and continue through year’s end, according to Township Engineer Jim Sullivan.

The Supervisors remain committed to maintaining safe roadways through annual road improvement projects. Each year Falls officials designate roads for upgrades.



Falls Adopts Fireworks Ordinance

With an eye on protecting the public's safety, the Falls Township Supervisors adopted an ordinance to set guidelines for the use of fireworks.

Under the local law, which mirrors the state law enacted in 2017, Falls Township residents interested in setting off fireworks may be permitted to do so, provided that guidelines are met.

Smaller fireworks, or so-called consumer fireworks, including roman candles, bottle rockets and other aerial fireworks, are permitted by individuals 18 years and older. Fireworks can not be set off within 150 feet of any structure that has a valid use and occupancy permit.

"It doesn't mean 'well, my neighbor's not home, so it's not occupied,'" Supervisors Chairman Bob Harvie said.

Harvie said the Supervisors opted to adopt the ordinance now because the Township has received fireworks complaints.

"It's a safety concern," he said. "It's not about not having fun or trying to interfere with people's good times."

Particularly with houses being situated closer together, the risk for fire is greater. Novelty fireworks caught a house on fire last year and caused it to burn down, Supervisor Vice Chairman Jeff Dence said.

"It doesn't mean it's not dangerous," Dence said. "It means, use common sense."

The ordinance prohibits the discharge of fireworks in, near or toward a vehicle. Fireworks should not be set off by anyone under the influence of alcohol or drugs.

Each violation of the local ordinance incurs a \$100 fine.

"If someone shoots off six fireworks on someone's street that's \$600," Harvie said. "(The fine is for) every single thing you shoot off."

Larger fireworks displays are allowed only by permit from the fire marshal.

Citing the township's noise ordinance, Harvie said fireworks are permitted until 10 p.m. on weekdays or 11 p.m. on weekends.

Before setting off fireworks in a field or other vacant property, Harvie noted that permission from the property owner is a must.

Tips For Safe Snow Removal

While enjoying the winter wonderland, remember these tips to help Falls Township crews clear the roads more quickly and efficiently:

- Mailboxes should be installed in accordance with U.S. Postal Service standards. Mailboxes installed incorrectly and, as a result are struck by a Township plow during snow removal operations, will be the sole responsibility of the property owner to repair.

- Move your vehicles out of the street and into private driveways (this also reduces the amount of snow you have to shovel).

- During any snow emergency, all vehicles must be removed from roadways.

- Wait to shovel your driveway until

the plows have completed their final pass along the curb line or edge of pavement. A pass or two through the neighborhood does not mean the Township is finished with snow removal and your effort to clear your driveway entrance might be wasted.

- Shovel to the right-hand side of your driveway to reduce the amount of snow pushed back onto your driveways by plows.

- Clear your sidewalk by shoveling and salting within 24 hours of the last evidence of precipitation.

- Do not throw snow from any sidewalk or driveway into the roadway. Doing so is illegal, and you will be cited.

- Keep all receptacles (trash and recycling) on the sidewalk, not in the street.

- If you have an inlet in front of your property, please assist the Township in keeping it clear of snow and ice. This will prevent ice from accumulating and reduce drainage issues when snow begins to melt.

Please be patient during the snow removal process while the Township's plow operators work to clear roadways. We are here to get the roads open for travel as quickly as possible. Please remember we try to plow the roads from curb to curb to open the roadway as wide as possible. Some residents have no grass buffer between the curb and their sidewalks and snow is plowed onto the sidewalk area. This cannot be avoided. Snow is plowed to the shoulder of the roads to clear the travel areas.

Stay Warm and Safe this Winter

There's something about the winter months and curling up with a good book by the fireplace. But, did you know that heating equipment is one of the leading causes of home fire deaths? With a few simple safety tips and precautions, you can prevent most heating fires from happening.

- Keep anything that can burn at least three feet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.

- Have a three-foot "kid-free zone" around open fires and space heaters.

- Never use your oven to heat your home.

- Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to local codes and manufacturer's instructions.

- Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.

- Remember to turn portable heaters off when leaving the room or going to bed.

- Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.

- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.

- Test smoke alarms at least once a month.

- Install wood burning stoves following manufacturer's instructions or have



a professional do the installation. All fuel-burning equipment should be vented to the outside to avoid carbon monoxide (CO) poisoning.

- Install and maintain CO alarms to avoid the risk of CO poisoning. If you smell gas in your gas heater, do not light the appliance. Leave the home immedi-

ately and call your local fire department or gas company.

Fact: Half of home heating fires are reported during the months of December, January and February.

How to Prepare a Home Fire Escape Plan

Smoke detectors are provided and installed free of charge to residents of Falls Township. If you need smoke detectors, please call **215-949-9000, ext. 255** to schedule an appointment to have them installed. **SMOKE DETECTORS SAVE LIVES!**

- Draw a map of your home. Show all doors and windows.

- Visit each room. Find two ways out.

- All windows and doors should open easily. You should be able to use them to get outside.

- Make sure your home has smoke alarms. Push the test button to make sure each alarm is working.

- Pick a meeting place outside. It

should be in front of your home.

- Make sure your house or building number can be seen from the street.

- Talk about your plan with everyone in your home.

- Learn the emergency phone number for your fire department.

- Practice your home fire drill!

- Make your own home fire escape plan.



Fast Facts From Waste Management...

...on Waste Removal

When should trash be placed at the curb?

Place trash and recyclables out after 6 p.m. the evening before your pickup day. Place containers so they are not blocked by parked vehicles.

What size containers should I use?

Household waste containers should be between 20 and 35 gallons and may not exceed 50 pounds in weight. Use up to 10 sturdy plastic or metal containers with handles and detachable lids. Recyclables should be placed in a recycle bin or can clearly marked as "Recyclables."

How do I dispose of leftover paint?

Evaporate latex paint by air-drying or mixing with kitty litter, shredded newspaper or other absorbent. Bag and put out with your regular trash.

Which wastes are not acceptable?

We do not accept liquid waste of any type, tree stumps or tires. We do not accept HHW of any type, including insecticides, pesticides, gasoline, waste oil, non-latex paints, varnish, thinners, drain cleaner, pool chemicals, car parts or similar materials as part of your regular waste removal services. Hold all Household Hazardous Waste materials for special HHW collection events.

...on Bulk Items

When are bulk items collected?

Larger items are collected on the second pickup day of the week, sometimes by a second crew.

What type of bulk items are collected?

Examples of regular bulk items include furniture, cabinets, washers and dryers.

How much can I discard at once?

The limit is one bulk item per week.

What about refrigerators?

Some items require an appointment, such as refrigerators, freezers, air conditioners and dehumidifiers containing CFCs. To make an appointment, call **800-869-5566**.

...on Holiday Pickups

What if my pickup day falls on a holiday?

If a scheduled holiday (Memorial Day, Independence Day, Labor Day, Thanksgiving, Christmas and New Year's Day) falls on your regular pickup day, trash and recyclables will be collected on your next regular service day.

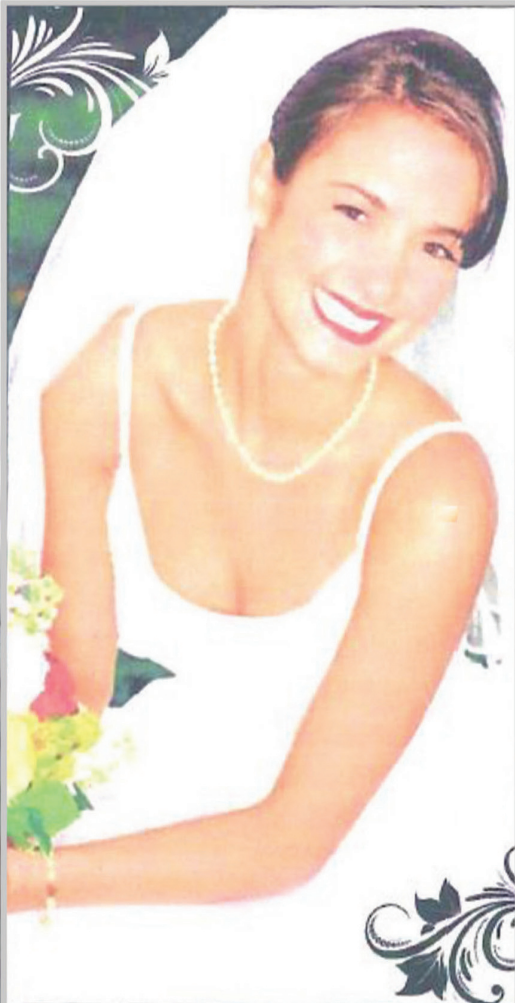
