Sam Snipes: A Seed of Bucks County

hen King Charles II signed the charter in 1681 to give William Penn the land that would become Pennsylvania, Penn stated that he believed his new colony would become "the seed of a nation." As with any seed, there is effort and care that must go into making sure something grows from it. Pennsylvania did become one of the most important colonies of the new world, and of the new United States less than 100 years later. Our own connection to William Penn surrounds us every day here in Falls Township. From Pennsbury Manor (and the school district named after it), to Three Arches and historic Fallsington, we have brick and mortar reminders of our history, and the first planting of that "seed" 338 years ago. This past December we lost one other connection to that history with the passing of Sam Snipes. Mr. Snipes would have turned 100 years old this year and his life is connected to both the founding of Pennsylvania and Falls Township, and with the care and effort it took to help ensure our growth and success.

On the wall of the Snipes home is a marriage license of one of Sam Snipes' ancestors bearing the signatures of witnesses to the wedding, which is the custom in Quaker weddings. One of those signatures is that of William Penn, who was an associate of Mr. Snipes' ancestor. Sam Snipes was the historian of our Township, having written "The History of Falls Township" 30 years ago, and his own family history made our history that much more important to him. Being the historian he was, and having the memory he did, I am sure Sam knew of Penn's quote about Pennsylvania being "the seed of a nation." The fact that the Snipes family has operated a farm for hundreds of years in Falls Township makes the "seed" analogy that much more perfect because Sam spent his life not only nurturing crops and animals, but also nurturing his family, community and country.

As an attorney, Mr. Snipes worked to promote justice and equality throughout Bucks County, most famously by defending the Myers family when they became the first African-American family to move into Levittown in 1957. As crosses were burned in Falls Township, Mr. Snipes was standing alone in front of the Myers home in Dogwood Hollow as an angry mob threatened to go through him and burn down the house. Sam didn't flinch, and the house stayed safe. Six years later, he would take his children to attend the March on Washington and hear Martin Luther King give his famous address. It was this same spirit of service that had led Sam to Europe after World War II to assist refugees who were starving and afraid. As an attorney for Falls Township he helped us develop into the economic engine that gave jobs to thousands of residents and led to the enormous growth of Bucks County. Later, he used his abilities to fight for our environment and preserve our history.

There have been many people throughout the history of our Township, county and state who have helped the "seeds" of our past grow into what we are today. And there continue to be people all around us who are still tending to the work needed to make our community and country the best it can be. Many of those who do this work do it without notoriety or fame. We should do a better job of noticing their efforts and sacrifices and thanking them. Sam lived as full a life as anyone could have and would not have liked the attention he has received since his passing. It was my pleasure to have gotten to know him a little bit over the past 20 years, and an honor to try my best to continue nurturing the "seed" planted so long ago.

Falls Township Police can provide your loved one with a SafetyNet bracelet that they should always wear. Water-proof bracelets feature a radio frequency transmitter that emits a continuous signal. If a loved one is missing, caregivers would contact authorities immediately. Trained search and rescue teams track the signal emitted from the bracelet, locate the missing person and return him or her home safely.

Radio frequency technology can work in densely wooded areas, building and shallow water, even when GPS and cellular technology can not.



Committee Works to Make Travel Safer



Are drivers zooming through your neighborhood faster than the speed limit permits? Do you often see motorists roll through stop signs or ignore them altogether?

Falls Township's five-member Neighborhood Traffic Advisory Committee seeks to address these and the public's other traffic-related concerns. Comprised of residents and local officials serving as a central point of contact, the NTAC receives and evaluates neighborhood traffic complaints. In instances of frequent or severe occurrences, the committee may recommend that the administration and Board of Supervisors consider implementing a traffic calming solution.

To address motorists' failure to come to a complete stop at stop signs, NTAC recommended the installation of new "Stop means Stop" signs. The committee also championed the new adaptive traffic signal at Lincoln Highway and Oxford Valley Road; and the PennDOT redesign project for the intersection near the Wawa on Bristol Oxford Valley Road.

In 2018, Falls Township had 1,346 traffic crashes. Five traffic fatalities occurred last year. Of those, two were pedestrian deaths and the others stemmed from motor

vehicle crashes. Many factors contribute to the likelihood of a vehicle crash. Speeding, running red lights, running stop signs, distracted driving, driving while impaired and tailgating are among the top causes of crashes – and are all preventable.

Beware of pool and spa dangers

You may be on vacation or away from home and be unfamiliar with the swimming facilities and the dangers that may be present from suction outlet entrapment or disembowelment. Many swimming facilities were designed with filters or circulation systems that allow suction so great, that a person can be held at the bottom causing serious injury or possible drowning. An infant or small child can be placed over a drain in a baby pool that could cause disembowelment.

Today's swimming facilities are supposed to be designed with dual drains, special covers, and/or vacuum breakers that will help prevent a suction outlet from having such suction that it could cause injury or possibly death.

Always be aware of the dangers that may be present by faulty drain grates or excessive suction. If you see a drain grate that is not properly placed or missing, let someone know right away. Your acknowledgment and reporting of a defective or missing drain grate may prevent an injury or even a drowning.



Falls Enacts Zoning Ordinance Updates

Just as the Lorax speaks for the trees in the Dr. Seuss children's story, so too do the Falls Township Board of Supervisors.

The governing body, in an effort to update its zoning ordinances, recently adopted revised regulations for various sections related to earth disturbance, regulation and placement of PODS and dumpsters, rights of way, and set tree protection standards.

Township attorney Lauren Gallagher said the earth disturbance update was a "complete rewrite" aimed at ensuring compliance with state regulations and requiring access to easements.

The ordinance related to PODS (Portable On Demand Storage) units, is a new one for the Township. It requires a permit and provides for a limited duration of use.

Supervisors Chairman Bob Harvie

said PODS are commonly used during home renovations, fire cleanup, or relocation. The ordinance was needed, he said, because "our ordinance says nothing about them," meaning that without the regulation the Township could not restrict where they can be located or duration of use.

The goal of the tree protection ordinance is to ensure that all permits for earth disturbance, demolition, building, subdivision, land development or zoning change application "shall respect existing trees as a natural resource," according to the ordinance. The regulation requires that applicants "preserve the healthy trees" onsite "whenever possible."

The ordinance aims to maintain existing trees and increase the tree canopy and understory on public and private property.

The provision prohibits clear cutting of trees. It also requires that all applications include a tree survey plan denoting each tree to be saved, lost or destroyed, the location of tree protection fences and the proposed tree replacement schedule. Any tree lost or destroyed within five years prior to an application submission must be replaced.

For the past few years, Falls Township staff and attorneys have combed through a three-ring binder containing the Township's zoning ordinance to determine which areas are most in need of updating.

"It really has been a few years of work," Harvie said, adding that Township staff and professionals have gone through "every one page by page and look for any inconsistency."





Board: Roads Part of Utility Repair

The Falls Township Board of Supervisors adopted an ordinance that could potentially make travel smoother – and safer – for motorists driving on roads that were recently opened for water main or other utility work.

The Board unanimously adopted an ordinance that would ensure that roads are adequately fixed following construction.

The so-called "curb to curb ordinance" requires that a developer or utility company repair the entire road, from curb to curb, following excavation on a portion of the street, according to Township attorney Lauren Gallagher.

Doing so ensures that the "pavement is even and

less likely to fall into repair," she said.

Supervisors Chairman Bob Harvie said roads that are patched in part tend to be "lumpy." Under the new ordinance, that will no longer be the case.

"This makes (the developer or utility company) have to do it," Harvie said. "They have to patch the entire road."

The ordinance sets standards for how contractors and utility service providers must repair roads once work is complete. Many other municipalities have similar ordinances in force.

The ordinance outlines various requirements, as well as penalties for delays. The amendments mandate that permanent paving



be constructed within 30 days after the installation of temporary paving. If defects appear within a year of the permanent installation as a result of defective restoration, Falls would require the applicant to pay for all necessary repairs.

On roads that are less than five years old, Falls would require that the applicant overlay the traffic lanes in which the opening was made for the entire length of roadway in instances where a longitudinal opening longer than 100 linear feet has been made in the pavement. In addition, when four or more openings

have been made by the same applicant within 100 linear feet of pavement, the applicant would be required to overlay traffic lanes in which the openings were made for the entire length of the highway

Regardless of the age of the road, if more than 100 feet of longitudinal or transverse openings, or both, are made in the pavement, Falls reserves the right to require the applicant to overlay traffic lanes for the entire road "if the Township engineer determines that the rideability or structural integrity of the pavement has been impaired by the openings," according to the proposed ordinance.

Falls Sets Wheels in Motion for Annual Road Program

With an eye on motorists' safety while traveling on Falls Township roadways, the Board of Supervisors voted unanimously to contract with Jones Engineering Associates to undertake various duties related to the Township's annual road program.

For 2019, Falls plans to carry out full depth reconstruction of five Township roads in the Hedgerow Woods section of Falls, including Fletcher Drive, Rice Drive, Lions Drive, Simons Drive and Gilbert Drive. In addition, a portion of Elbow Lane between Stony Hill Road and the Falls Township boundary has

been designated for mill and overlay improvements.

Road work is typically undertaken sometime in the spring



or summer months once weather is consistently above freezing.

As part of the company's proposal, the engineering firm would prepare design, bid and construction documents for the road program improvement project and would also prepare the project specification, bid schedules, advertisements and attend pre-bid meetings. Jones Engineering Associates would also obtain professional surveying and base mapping services and perform a PA One-Call for all available information related to the various underground utilities that could be present in the work

zone. Cost of the company's services related to this project is \$294,500.

Public Works at Work For You

The Falls Township Public Works Department is responsible for many tasks aimed at providing a superior service to Falls Township residents. Public Works achieves this by maintaining and improving the Township's infrastructure, as well as providing support to other Township Departments.

The Public Works Department is involved in many aspects of the Township's operations. The department works with the Parks and Recreation Department, Fire Marshal's Office, Code Enforcement and the Police Department to ensure the best possible service and an enhanced quality of life to Falls Township residents.

Falls Township Public Works asks that property owners maintain their roadside landscaping and trees. Roadside landscaping and trees that are not maintained and protrude into the roadway become a safety issue for pedestrians and motorists using Township roadways. All roadside landscaping and trees shall be trimmed back approximately 1 foot behind the face of the curb line or edge of pavement and to a minimum height of 13 feet. Corner property owners and owners that reside on the inside curvature of a roadway shall take extra care to make sure their landscaping does not interfere with sight line distances.



Properly maintained landscaping allows for safe passage of pedestrians and motorists using our roadways.

Falls Seeks Grant to Improve Intersections

With an eye on improving public safety at intersections, the Falls Township Board of Supervisors set the wheels in motion for the submission of a Penn-DOT grant to cover the bulk of upgrades at West Trenton and Alden avenues, as well as the installation of a solar-powered flashing school zone system at Fallsington Elementary School.

The board approved a proposal from Remington & Vernick Engineers for grant writing services related to the projects. The firm completed a Green Light Go Program application and submitted it to PennDOT along with supporting documentation, as well as a scope of work for the projects and cost estimates.

If the grant is approved, Falls would be required to provide a 20 percent match.

In terms of improvements, the intersection of West Trenton and Alden avenues would be made handicap accessible. The lights would be re-signalized, re-timed and the intersection would be reconfigured, according to Christopher Fazio, Remington & Vernick executive vice president.

At the Fallsington Elementary School location, the addition of a solar-powered flashing school zone system would provide added safety and help to slow speeds

down, Fazio said.

Falls has been successful in obtaining Green Light Go grants previously, including funds to improve the traffic signalization at Mill Creek and Levittown parkways.

"We've done all of the major intersections," Supervisor Chairman Bob Harvie said.

The governing body had considered installing flashing signals at Fallsington Elementary School previously, but found prices to be "really, really high," according to Harvie. The state grant would cover 80 percent of the expense, making it much more affordable.

Working smoke alarms save lives. However, people who are deaf or hard of hearing may not be able to depend on the traditional smoke alarm to alert them to a fire.



Install smoke alarms in every bedroom. They should also be outside each sleeping area and on every level of the home. For added safety, interconnect all the smoke alarms. If one sounds, they all sound. This gives people more time to escape.

SAFETY TIPS

- Smoke alarms and alert devices are available for people who are deaf or hard of hearing.
- Strobe lights flash when the smoke alarm sounds. The lights warn people of a possible fire.
- When people who are deaf are asleep, a pillow or bed shaker can wake them so they can escape. The shaker is activated by the sound of a smoke alarm.
- When people who are hard of hearing are asleep, an alert device that uses a loud, mixed, low-pitched sound can wake them. They may find a pillow or bed shaker helpful. These devices are triggered by the sound of the smoke alarm.
- Research the products and select the ones that best meet your needs.

WHERE TO FIND EQUIPMENT

Search home improvement store websites or use a general search engine to look for strobe light smoke alarms. BRK/First Alert, Gentex, and Kidde brands offer this type of smoke alarm. Find smoke alarm accessories such as pillow or bed shakers, transmitters, and receivers at **lifetonesafety.com**, **safeawake.com** and **silentcall.com**. Choose devices that have the label of a recognized testing laboratory.



FACT

Home fire sprinklers keep fires small. This gives people more time to escape in a fire.

AND DON'T FORGET...
Test all smoke alarms at least once a month using the test button.



When a CFL Burns Out

- When a CFL bulb burns out it may smoke and the plastic base may blacken. This is normal and is not a fire safety issue.
-))) CFLs should never be discarded with household trash. The Environmental Protection Agency recommends that consumers use local

recycling options for CFLs. Contact your local government or visit **epa.gov/cfl/cflrecycling** to identify local recycling options.

If a CFL Breaks

CFLs are made of glass and can break. Be careful when removing from packaging and installing or removing from a socket. If a CFL breaks:

- OPEN a window to allow the room to air out for 5–10 minutes.
- People and pets should LEAVE the room.
- TURN OFF forced air heating and/or air conditioning.
- COLLECT broken glass and visible powder using stiff cardboard, tape or a damp paper towel.
- PLACE the debris in a glass jar or a plastic bag in a safe location outside until you can dispose of it.
- CONTACT your local government to find out how to dispose of the debris
- CONTINUE airing out the room for several hours.

CFL bulbs contain a small trace of **mercury** within the glass. When broken, mercury will immediately dissipate into the air. Concentrations of mercury will likely approach zero in an hour or so.

Lithium ion batteries supply power to many kinds of devices including smart phones, laptops, scooters, e-cigarettes, smoke alarms, toys, and even cars. Take care when using them. In rare cases, they can cause a fire or explosion.

The problem

- These batteries store a large amount of energy in a small amount of space.
- Sometimes batteries are not used the right way; batteries not designed for a specific use can be dangerous.
- Like any product, a small number of these batteries are defective. They can overheat, catch fire, or explode.

Safety Tips

- Purchase and use devices that are listed by a qualified testing laboratory.
- Always follow the manufacturer's instructions.
- Only use the battery that is designed for the device.
- Put batteries in the device the right way.
- Only use the charging cord that came with the device.
- Do not charge a device under your pillow, on your bed or on a couch.
- Keep batteries at room temperature.
- Do not place batteries in direct sunlight or keep them in hot vehicles.
- Store batteries away from anything that can catch fire.

Signs of a Problem

Stop using the battery if you notice these problems: odor, change in color, too much heat, change in shape, leaking, odd noises. If it is safe to do so, move the device away from anything that can catch fire. Call **9-1-1**.

Battery Disposal

- Do not put lithium ion batteries in the trash.
- Recycling is always the best option.
- Take them to a battery recycling location or contact your community for disposal instructions.
- Do not put discarded batteries in piles.

High-Tech Luggage

Some major airlines no longer accept 'smart' luggage with non-removable lithium ion batteries as checked or carry-on luggage. The powerful batteries can potentially overheat and pose a fire hazard during flight.

In some instances, smart bags with removable lithium ion batteries will be allowed on board if the battery can be removed on site and taken on board with the customer. Check with your airline for restrictions.

Fast Facts From Waste Management...

...on Waste Removal

When should trash be placed at the curb?

Place trash and recyclables out after 6 p.m. the evening before your pickup day. Place containers so they are not blocked by parked vehicles.

What size containers should I use?

Household waste containers should be between 20 and 35 gallons and may not exceed 50 pounds in weight. Use up to 10 sturdy plastic or metal containers with handles and detachable lids. Recyclables should be placed in a recycle bin or can clearly marker as "Recyclables."

How do I dispose of leftover paint?

Evaporate latex paint by air-drying or mixing with kitty litter, shredded newspaper or other absorbent. Bag and put out with your regular trash.

Which wastes are not acceptable?

We do not accept liquid waste of any type, tree stumps or tires. We do not accept HHW of any type,, including insecticides, pesticides, gasoline, waste oil, non-latex paints, varnish, thinners, drain cleaner, pool chemicals, car parts or similar materials as part of your regular waste removal services. Hold all Household Hazardous Waste materials for special HHW collection events.

...on Bulk Items

When are bulk items collected?

Larger items are collected on the second pickup day of the week, sometimes by a second crew.

What type of bulk items are collected?

Examples of regular bulk items include furniture, cabinets, washers and dryers.

How much can I discard at once?

The limit is one bulk item per week.

What about refrigerators?

Some items require an appointment, such as refrigerators, freezers, air conditioners and dehumidifiers containing CFCs. To make an appointment, call (800) 869-5566.

...on Holiday Pickups

What if my pickup day falls on a holiday?

If a scheduled holiday (Memorial Day, Independence Day, Labor Day, Thanksgiving, Christmas and New Year's Day) falls on your regular pickup day, trash and recyclables will be collected on your next regular service day.
