#### ITEM #1: PLAN REVIEWS

• NP Falls Township Industrial, LLC, at Keystone Trade Center Lot 20

- Requested variances include:
  - Waiving preservation of 85% of areas with steep slopes greater than 25%. The existing swale contains man-man steep slopes which will be regraded for the construction of warehouse building #20 for the driveway and utility connections.
  - Waiving installation of sidewalk along the project street frontage as there are no existing sidewalks to connect to on either side of the property.
- No concerns were expressed
- Sunbelt Forest Products at 400 Rock Run Road, Fairless Hills
  - Requested variances include:
    - Requiring Sidewalks since the existing frontage along the street does not provide adequate room for sidewalks and associated site grading.
    - Requiring 15 feet between parking curbline and building since 0 feet is proposed where the existing parking adjoins the proposed building addition (existing nonconformance).
    - Permitting a maximum of 20 parking spaces between landscape islands.
       54 parking spaces are proposed without a landscape island since these parking spaces are located in an existing paved area.
    - Parking areas tree requirement since there are existing trees located along the existing paved area that is proposed to be striped for parking, largely meeting this requirement
    - Required lighting, since current lighting is mounted on the existing structures, which provides lighting for the operations of the facility. The proposed structures will include lighting consistent with the existing structures, provided on structure plans.
  - No concerns were expressed
