Old Business

New Business

- Water Quality Fund mini-grant opportunity: Bucks County Conservation District recently approved a grant program to encourage partnership among municipalities, their EACs, non-profit and civic organizations. The grants will be awarded to projects that support their mission of soil and water conservation a big umbrella that includes stormwater management, naturalized green space for passive recreation, education/outreach, community science, tree planting projects, basin naturalizations, and more. A 50% match is required and can be fulfilled by in-kind labor or cash match. The application deadline was due June 15, 2025.
- Amazon Data Center at 600 Ben Fairless Dr, Fairless Hills. The Department of Environmental Protection invited comments in June on an Air Quality Plan Approval Permit covering the installation of 72 - 2.5 MW diesel-fired emergency generators (180 MW total) and two 750 kW diesel-fired house emergency generator engines at the new Amazon Data Services Inc. data center in Falls Township, Bucks County.
